Pursuant to IRC Section 881(e) and 871(k), the total percentage of ordinary dividends that is exempt from U.S. withholding is 96.53% as broken down as follows:

- Percentage of ordinary dividends that represent qualified interest income pursuant to IRC Section 871(k)(1) = 95.39%
- Percentage of ordinary dividends that represent short term capital gain pursuant to IRC Section 871(k)(2) = 1.14%

Distributions that were reinvested through the Company's Dividend Reinvestment Plan are treated, for tax purposes, as if they had been paid in cash. Therefore, stockholders who participated in the Dividend Reinvestment Plan should also refer to the table above for appropriate tax treatment of 2017 dividends.
