Golub Capital BDC, Inc. Tax Status of Distributions in 2019

The information on dividends paid by Golub Capital BDC, Inc. (“Golub Capital BDC” or the “Company”) (CUSIP Number: 38173M) for 2019 is set forth below. For tax purposes, the Company is a regulated investment company (“RIC”) and is designating the types of distributions you received as a stockholder in 2019 in the following manner:

DETAILS OF DISTRIBUTIONS IN 2019

The amounts shown in the table below represent the **final** accounting of the Company’s 2019 distributions. These distributions were classified as follows:

Note: The dividend paid on 12/30/2019 includes a special distribution of \$0.13 per share.

Pursuant to IRC Section 881(e) and 871(k), the total percentage of ordinary dividends that is exempt from U.S. withholding is 99.77% as broken down as follows:

- Percentage of ordinary dividends that represent qualified interest income pursuant to IRC Section 871(k)(1) = 99.05%
- Percentage of ordinary dividends that represent short term capital gain pursuant to IRC Section 871(k)(2) = 0.72%

Distributions that were reinvested through the Company’s Dividend Reinvestment Plan are treated, for tax purposes, as if they had been paid in cash. Therefore, stockholders who participated in the Dividend Reinvestment Plan should also refer to the table above for appropriate tax treatment of 2019 dividends.
